The Preliminary Round of shall be played on Zonal basis from 4th September 2014 and the Final Round Matches at Dibrugarh University Campus, form 12rd September to 16th September 2014.

Kindly note that the participating Colleges in the Zonal matches has to submit the below mentioned documents to the Observer of the respective Zone and the qualified teams for Inter Zonal Competition shall have to submit the same to the Sports Board Office at the venue of the Inter Zonal Matches.

- 2. College Flag**

The Zonal winners and the last year's Winner and Runner-Up colleges shall qualify for the Final Round. For final round Matches unfurnished dormitory type accommodation will be provided for the teams for 18 (Eighteen) players and 2 (Two) officials only as per the rules of AIU and D.U. Sports Board. For food etc. the teams shall have to make their own arrangement. Kindly instruct your College Football Team to bring necessary **Bedding, Mosquito net** etc. along with them. **Prof.-in-Charge** is must in a team.

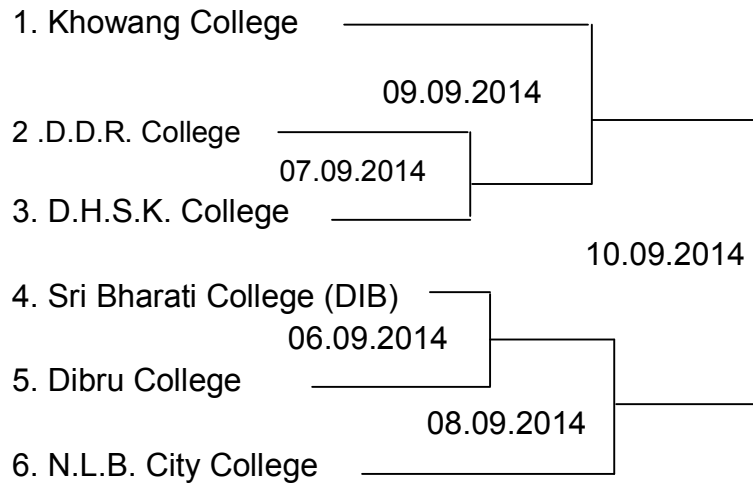

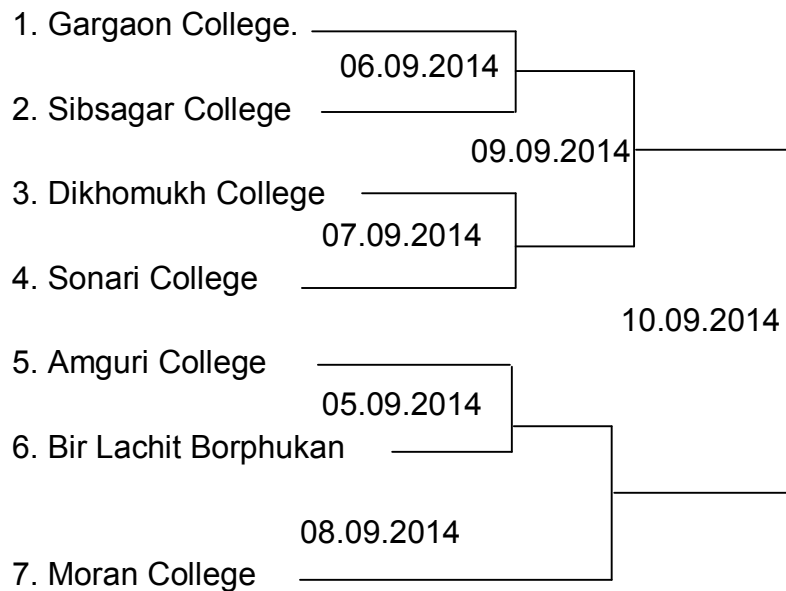

ZONE – A Venue: - Dibrugarh University.



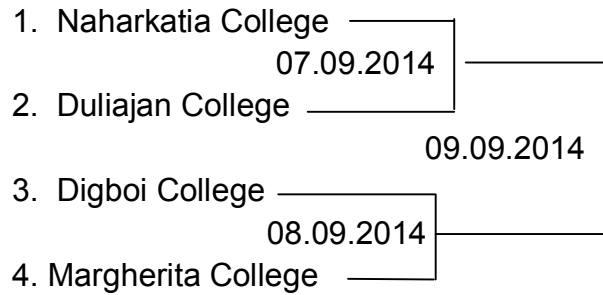

ZONE – B Venue: - Sonari College.



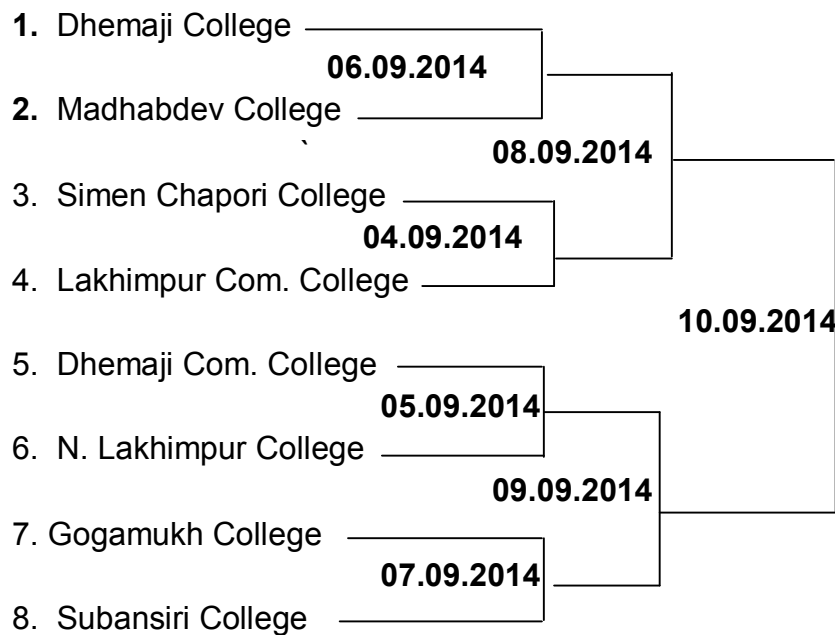

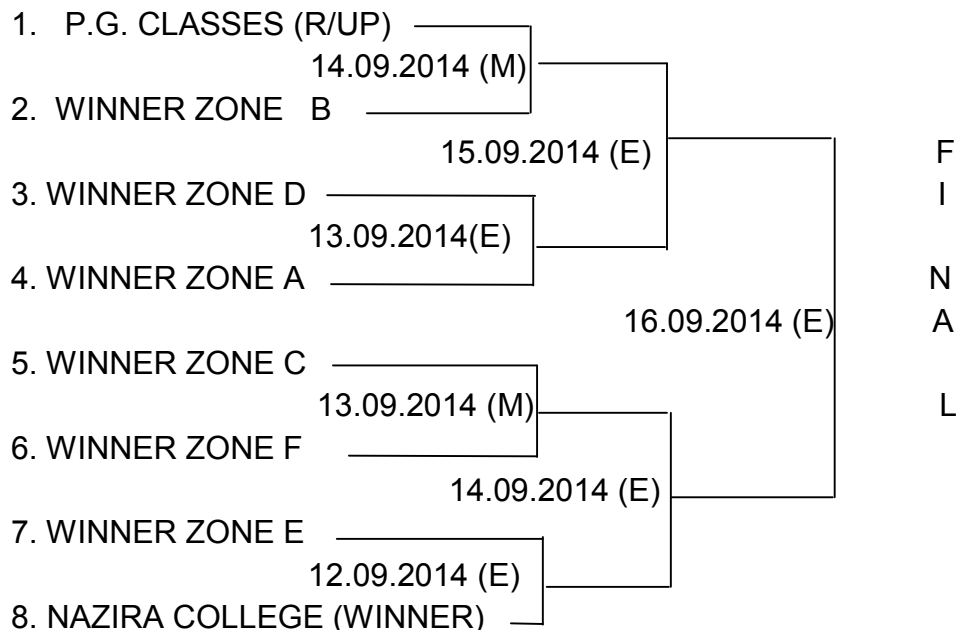

IMPORTANT NOTICE (Applicable for zonal Matches only)

1. The Team should report in the venue at least one hour before the starts of the matches.
2. As per as practicable, qualified referees of AFA should be appointed. In case of none availability of qualified referees, organizer may arrange referees in consultation with the Observer and the teams.
3. The expenses on referees in terms of remuneration, T.A. etc. shall be shared by both the teams. This is applicable for the Zonal matches only.
4. The Zonal organizer shall arrange referees, accommodation of the team, field etc. if necessary. Other expenses shall have to be borne by the participating teams.
5. If any observer fails to report in time, the match shall be played with mutual arrangement of both the teams.
6. Players has to produce the original admit card of the HSLC and I-Card before commencement of the match.
7. Decision of the Football Sub-Committee / Tournament Committee shall be final and binding.
