**1) Assistant Professor in Commerce(contract basis) -----1 (one) Post**  
**Eligibility:**

- (i) A Master's Degree with at least 55% of marks or its equivalent grade of B in the seven point scale.

A relaxation of 5% may be provided at the graduate and master's level for the Scheduled Caste/ Scheduled Tribe/ Differently-abled (Physically and visually differently-abled) categories for the purpose of eligibility and for assessing good academic record.

- (ii) Qualifying in the national level test conducted for the purpose by the UGC or any other agency approved by the UGC. However, candidates who are, or have been awarded Ph.D. Degree in accordance with the "University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree), Regulations 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/ SLET/ SET.
