2ND ADMISSION NOTICE FOR THE 5 YEAR INTEGRATED BA LLB(H) and LLM PROGRAMMES SESSION 2016-2017

Applications in prescribed Form are invited from the intending eligible candidates for admission into the following seats of **5 Year Integrated BA LLB(H) and LLM Programmes** of Dibrugarh University for the session 2016-2017:

5 Year Integrated BA LLB(H):

LLM:

Eligibility:

a) 5 Year Integrated BA LLB

Eligibility: A candidate must have passed the Higher Secondary (10+2) or the equivalent Examination securing at least 45% marks in aggregate. (40% Marks in case of SC, ST and OBC Candidates)

Mode of Selection: Through Admission Test and Viva-voce (All the Marksheets & Certificates are required to be produced in original at the time of Viva-voce.)

b) LL.M.

Eligibility: A candidate must have 50% marks in aggregate in 3-Year LL.B. or 5-Year BA/B.Sc./B.Com./BBA LLB. Programme recognized by University Grants Commission (UGC) and Bar Council of India (BCI).

The candidates appearing the Final Examination of the aforesaid Programmes may also apply but they must produce the Mark Sheet and Certificate of Degree in original at the time of admission.

Mode of Selection: Through Admission Test and Viva –voce

Dibrugarh University Statutory Reservation Policy shall be followed in admission in case of reserved category candidates.

How to Apply:

1. Please download the Application Form along with the Copy of the prescribed Bank Challan, which is available in the Dibrugarh University website www.dibru.ac.in and fill up with all details carefully.
2. Deposit **Rs.500/-** as the Application Fee at **any branch** of the **Punjab National Bank** or **State Bank of India** using the prescribed Bank Challan available with the Application Form. *Candidates willing to deposit the Fee at any Branch of the State Bank of India shall have to pay an additional amount of Rs.60/- as bank charge, which is not required if the Fee is deposited at any Branch of the Punjab National Bank.*
3. Submit the duly filled in Application Form accompanied by self-attested copies of all relevant documents along with the University Copy of **Fee Deposit Receipt** at the **Centre for Juridical Studies, Dibrugarh University** on or before **09.08.2016**.
4. Please fill up the format of the **Admit Card for Admission Test** given in the last page of Application Form and submit the same at the time of submission of your filled in Application Form with necessary information. Please collect it again from the Office of the Centre after issuance of a Test Roll No. by the University.
