Guidelines for Contributors

1. The manuscript must be strictly related to legal issues within 6000 words with an Abstract (not more than 200 words). 4-5 keywords must also be mentioned
2. The full manuscript should contain introduction, objectives, methodology, discussion and conclusion. The abstract should state the objective of the study, issues involved and the conclusions briefly.
3. The manuscript should be prepared in *Times New Roman* and *Font Size-12*, with *1.5* line spacing.
4. The manuscript prepared as per the guidelines shall be processed for review by experts of the concerned field.
5. A paper shall be published only on the recommendation of the reviewer. Submission of paper does not mean automatic acceptance.
6. All accepted manuscript shall be the property of Dibrugarh University including copyright but Editorial Board and the Publisher shall not be responsible for plagiarism committed by any author.

Books:

Author's name, Title of the book (in italics), (Place of publication: Publisher's name year) page for example-William, *Human Health and Environment*. (Allahabad: Allahabad Law Publications 2011) p 79.

Collection of articles/papers in book:

Author's name, Title of the paper in: Editor's name, Title of book (in italics), Place of publication: Publisher's name year) page

For Example-Wilkinson, Right to Access Medicine and IPR in: Williams, *Human Health and Environment*. (Delhi SPS Publications 2011) 97.



Newspaper:

Author's name, Title, date(day), name of newspaper (in italics), page

For example-Upendra Baxi, Separation of Powers, 27th May 2011 (Friday) *The Legal Observer*. 2

Website :

Author's name "Title of the Paper", vol-Issue-, year name of Journal (in italics) page available at website address

For example- Williams, "Child Rights in India", vol. 5 Issue 2, 2011 *Journal of Law Institute* 22-52 .
