Online Applications are invited from eligible intending candidates for admission to the Four Semester MBA (Full Time) Programme at Centre for Management Studies, Dibrugarh University for the session 2016-2018

Eligibility: Graduation (All streams except Music & Fine Arts) with 50% marks (45% for SC/ST). Candidates with valid score of above 550 in MAT, above 117 in CAT and above 175 in CMAT are exempted from CMSDU Test. Final year graduate students may also apply.

Application Procedure: The candidate will be required to submit a Demand Draft of Rs 650/- only [Rs. 400/ for candidates seeking exemption from CMSDU Test] in favour of **“Registrar, Dibrugarh University” payable at Dibrugarh.** It is advised that Demand Draft be made ready before attempting to register online.
