3. Candidates must appear **before the Admission Committee** on 1<sup>st</sup> of August, 2017 at 10.30 A.M. in the office of the Chairperson, Centre for Juridical Studies, Dibrugarh University.
  4. The candidates provisionally selected under reserved categories shall have to produce the Permanent Residence Certificate of Assam.
  5. In service candidates are required to submit a NO OBJECTION CERTIFICATE from his/her employer to take admission into LL.M programme.
  6. The candidates shall have to deposit requisite Admission, Course Fees etc. on the date of admission. The total Fee is **Rs. 26,380/.**
  7. Few seats under the reserved categories are lying vacant for which fresh advertisement will be issued later.
