### DIBRUGARH UNIVERSITY



(Established under the Dibrugarh University Act, 1965)

Dibrugarh University, the easternmost University of India was set up in 1965 under the provisions of the Dibrugarh University Act, 1965 enacted by the Assam Legislative Assembly. It is a teaching-cum-affiliating University with limited residential facilities. The University is situated at Rajabheta at a distance of about five kilometres to the south of the premier town of Dibrugarh in the eastern part of Assam as well as India. Dibrugarh, a commercially and industrially advanced town in the entire north-eastern region also enjoys a unique place in the fields of Art, Literature and Culture. The District of Dibrugarh is well known for its vast treasure of minerals (including oil, natural gas and coal), flora and fauna and largest concentration of tea plantations. The diverse tribes with their distinct dialects, customs, traditions and culture form a polychromatic ethnic mosaic, which becomes a paradise for the study of Anthropology and Sociology, besides art and culture.

The Dibrugarh University Campus is well linked by roads, rails, air and waterways. The National Highway No.37 passes through the University Campus. The territorial jurisdiction of Dibrugarh University covers seven districts of Upper Assam, *viz.* Dibrugarh, Tinsukia, Sivasagar, Jorhat, Golaghat, Dhemaji, Lakhimpur, majuli and charaideo

The University Campus extends over an area of more than 500 acres of which 60 acres are still covered under tea plantation. The University is re-accredited by National Assessment and Accreditation Council (NAAC) in 2017 with CGPA of 3.16 on 4 point scale at 'A' Grade. Dibrugarh University is a member of the Association of Indian Universities (AIU) and recognised by all Universities in India and abroad on reciprocal basis.

#### **VISION OF THE UNIVERSITY:**

The Dibrugarh University shall motivate and strive for the creation of innovative, competent and compassionate human resources for sustainable and holistic development for achieving social harmony and ensuring quality living so that the University remains as a centre of excellence and continues to generate, disseminate and apply new knowledge and techniques through state of the art education and research in consonance with societal relevance and changing paradigms.

#### **ACADEMIC ASPECTS:**

The University, through the various teaching Departments, Centres of Studies in its campus and the affiliated colleges scattered over the seven districts, is imparting higher education in the various branches of learning in Arts, Commerce, Engineering, Medical, Pharmaceutical Sciences, Law, Science & Technology, Computer Sciences, Management and Teachers' Training.

In the University Campus, at present there are 17 Teaching Departments and 17 Centres of Studies teaching subjects in Arts, Science, Technology, Commerce, Management, Pharmaceutical Sciences, Law and Education leading to the LL.M., M.A., M.Sc., M.Tech., M.Com., M.B.A., M.C.A., M. Pharm., M.Ed., M.L.I.Sc., B.Ed., B. Pharm., B.B.A., B.C.A., 5-Year B.A. LL.B. (Hons), B.Sc.(IT), and B.L.I.Sc. degrees. Some of these Departments/Centres also conduct Diploma Courses like the two year Diploma Course in Tai-Language, Post Graduate Diploma in - Computer Application (PGDCA), Statistical Techniques and Computation (PGDSTC), Tea Technology and Plantation Management (PGDTTPM), Tourism Management (PGDTM), Journalism and Mass Communication (PGDJMC), Electronic Preparation of Mathematical Language (PGDEPML), Diploma in Oil-Well

Drilling Technology (DOWDT), Advanced Post Graduate Diploma in - Atmospheric Physics (APGDAP), Telecommunication (APGDT), Petroleum Exploration Geo-Physics, Nano Science and Composite Materials, Applied Psychology etc. Dibrugarh University has also introduced Five Year Integrated M.Sc. in Physics.

Dibrugarh University with financial assistance received from the Department of Electronics (DoE), Govt. of India under its Employment Generation Training Schemes Level, Repair and Maintenance of PC Hardware's and Repair and Maintenance of Consumer Electronic Equipment.

Besides teaching the above mentioned Courses, the University offers M.Phil programme in ten subjects and encourages research in all departments for the Degree of Ph.D.

The University has introduced Master of Laws (LL.M.) programme from the Academic Session 2012-2013 through its constituent Centre for Juridical Studies.

#### Academic session:

The academic session for the  $1^{st}$ ,  $3^{rd}$ ,  $5^{th}$ ,  $7^{th}$  and  $9^{th}$  semester will normally commence as far as possible from  $1^{st}$  August while for  $2^{nd}$ ,  $4^{th}$ ,  $6^{th}$ ,  $8^{th}$  and  $10^{th}$  semester will normally commence from the  $1^{st}$  February every year.

#### **Facilities:**

#### Health service and health Insurance

The centre for juridical studies requires that every student have health insurance coverage. The excellent health care facilities provided by Dibrugarh University health Centre ensures that the students are adequately protected against sudden health emergencies with health insurance.

#### Conference hall

The centre has modernised well equipped (with LCD Projector) conference hall with a seating capacity of 200 to conduct seminars, Workshops, invited talks, functions etc.

#### Law Library and Computer Lab:

A library is the heart of an educational institution and believing in that the library of the centre has a vast collection of books, journals, E- Journals, digital library. Periodical and magazines to cater the demand of the students and also is a prime source for legal study and research for both the faculty as well as students. Housed at the ground floor of the building, the library provides the optimum study environment wherein students can study in solicitude and comfort. Along with it students can also use the facilities provided by the Central Library of Dibrugarh University. A computer lab is also attached with the library of the centre with broadband connectivity for the use of the students.

#### Legal aid and awareness:

The centre undertook legal awareness camps in and around Dibrugarh district as a part of tits legal aid activities. Recently the legal aid clinic of the centre has been approved and adopted by the District legal service authority, Dibrugarh, Govt of Assam for conducting various activities relating to legal awareness and legal aid. The centre also conducts various such programmes in association with leading NGO's also. The activities of the centre are run by a senior faculty member with the help of students.

#### Faculty:

The faculty of the Centre is drawn from some of the best Law Institutions of the country such as Symbiosis Pune, Gauhati University, ILS Law College Pune, Banaras Hindu University, Aligarh Muslim University, LucknowUniversity etc.

#### **Course Curriculum:**

The curriculum of the B.A.LL.B(H) course is designed keeping in mind the norms of BCI & UGC. The curriculum gives utmost importance to practical and seminar papers apart from regular theoretical papers. The curriculum also has a paper on Legal Research in order to develop research aptitude among the students.

#### Law Publication:

The Centre for Juridical Studies publishes an Annual Peer reviewed Refereed Journal of Law. The Journal received the International Standard Serial No. (ISSN) in 2009. It is the first Law Journal having an ISSN No. in the State of Assam. Along with articles from Academicians, Judges and Legal Luminaries the Journal also has a section for student articles. The editorial board of the journal consists of distinguished academicians from various reputed International Universities.

#### **Moot Court:**

Mock-trial and Moot Court are of paramount importance in today's legal education system and with the objective to facilitate standards of excellence in the sphere of mooting. The Centre provides a well-designed Moot Court Hall in the Second floor of the Building.

#### Eligibility:

**For B.A.LL.B. (H):** A candidate for admission to the Five- year B.A.LL.B. (Hons) Course shall have passed the Higher Secondary Examination (10+2) or an equivalent examination securing at least 45% in aggregate of the total marks. Provided that there shall be a relaxation of 5% marks for SC/ST and 3% for OBC candidates.

#### **Admission Procedure:**

The admission to the aforesaid Programmes will be made only on merit basis through an Admission Test and (viva-voce/wherever applicable) to be conducted by the University. Admission cannot be claimed by any applicant as a matter of right. On being selected for admission, the applicant has to appear before admission committee at the Centre for Juridical Studies, Dibrugarh University with all original certificates, mark sheets and other requirements on scheduled date and time. If any selected candidate is unable to appear personally, he may send his authorized representative with the required documents. If any applicant fails to deposit prescribed fee within the stipulated time, his/her admission will automatically stand cancelled.

If any selected candidate or his authorised representative does not appear before Admission Committee on scheduled date and time, his/her candidature shall be deemed to be cancelled without any intimation in writing.

#### Attendance:

A student must have minimum attendance of 80% for LL.M. and 70% for B.A.LL.B. (H) in the concerned semesters failing which the student will disqualify to appear in End-Semester Examination.

#### Method of Answering in the admission Test:

At the beginning of test, the applicants shall be provided a Question Paper and after that within 10 minutes, the applicant has to check the Question Paper to ensure that it contains all pages in sequence and there is no missing of questions/pages. If there is any error, the applicant has to promptly inform the invigilator who will provide fresh Question Paper. The applicant has to fill basic information in Question Paper at proper places. The answers must be responded in question paper itself through tick mark [ ] with black/blue ball point pen ONLY. USE OF PENCIL IS TOTALLY RESTRICTED.

Each question will have four alternative answers- A, B, C, D. The applicant is required to identify only one which he/she feels to be the correct answer and record the answer by ticking with Blue/Black Ball Point pen only, as mentioned above. The applicants will not be allowed to take Question Papers with them. An applicant has to return Question Paper to the invigilator after completion of the scheduled time. If any applicant ticks more than one option, the answer will be treated as incorrect. No page from the Question Paper is to be torn or removed. If a candidate is found tearing any page from the Question Paper he/she shall be liable for punishment for adopting unfair means and shall not be allowed to continue in the Admission Test.

#### **Evaluation and Result:**

Each question will carry two marks. The Viva-voce will carry 20 marks. There will be no negative marking. The University will display result of Admission Tests on notice board of the Centre for Juridical Studies and University website. There is no provision of individual notice to the candidates regarding their marks in Entrance Test. Hence, candidates are required to up-date themselves. No other mode of communication will be adopted. In case of equal marks in Admission Test, the preference will be given to the applicant with higher marks in qualifying examination.

#### **Medium of instruction:**

The medium of instruction shall be *ONLY* English.

#### **Important for Applicants:**

- The applicant has to reach at Admission Test centre with Admit Card preferably before 30 minutes of scheduled time.
- After 15 minutes of commencement of the Test, no applicant will be allowed to enter into the Examination Hall.

- No applicant shall be allowed to leave the Examination Hall except in case of any emergency with permission of the invigilators.
- Adopting unfair means during Test will attract penal actions. In ExaminationHall, talking with other applicants, using prohibited materials, usingmobiles/electronic devices, tampering with Admit Cards, canvassing in anyform are *PROHIBITED*. MOBILES/BLUETOOTH/ELECTRONIC DEVICES INEXAMINATION HALL IS TOTALLY PROHIBITED. THE UNIVERSITY DOESNOT TAKE ANY RESPONSIBILITY REGARDING CUSTODYOF THESE DEVICES. So,the applicants are advised not to bring their mobiles/Bluetooth/any otherelectronic devices into the examination hall.
- Any applicant, during test, may be checked by invigilator or any authorized person.
- Except authorized person of the University for the purpose of Test, no one shallmove around the Entrance Test venue.
- Application Forms of those applicants who have submitted forged/fake certificates or adopted fraudulent means shall be REJECTED without any formal notice and the concerned applicant shall be debarred from appearing in any entrance test of the University.
- Applicants are allowed to appear in Admission Test provisionally which is subject to final verification of all original certificates/mark sheets/caste certificates etc.
- Allowing for Entrance Test does not entitle to any applicant to claim for admission as a matter of right, if he/she does not fulfil all required criteria prescribed by the University.
- The University may cancel admission of any applicant subsequently at any stage if it is found at any time during the programme that the applicant does not fulfil minimum eligibility, made false documentation and submitted falsedocuments.
- SCRUTINY/REVALUATION OF ANSWER SHEETS OF B.A.LL.B.(Hons)/LL.M. ENTRANCE TESTIS NOT ALLOWED IN ANY CIRCUMSTANCES.
- Any litigation in respect of Admission Test shall be subject to jurisdiction of Dibrugarh court.
