NOTIFICATION

The hon'ble Vice-Chancellor, Dibrugarh University is pleased to approve partial modification in the B. Mus (Satriya) Degree Course Regulations, 1996 in order to specify the academic qualifications of the Principal, Lecturer, Instructor and Demonstrators required for conducting the B.Mus. Programme as below under report to the Board of Studies, Under Graduate Board and Academic Council, Dibrugarh University. These modifications shall come into immediate effect.

9. Norms for Affiliation/ Permission of B.Mus (Satriya) Colleges


Teaching Staff : Minimum three teachers for each elective Group to be headed by a Principal.

Qualifications:

- 1) Principal : a) M. Mus. or Master Degree in any discipline with minimum of 55% marks
b) He/she must have the knowledge of Sattriya Music & Dance.
c) The incumbent may possess a doctoral degree in any branch of Sattriya Music & Dance.
- 2) Lecturer : a) M. Mus. (Sattriya) in respective subject, with Minimum of 55% marks.
b) In case M. Mus. (Sattriya) is not available, the person having Master Degree in any discipline with minimum of 55% marks and theoretical & practical knowledge of respective subject, who have ability to explain the subject well.
- 3) Demonstrator : a) B. Mus. (Sattriya) Degree from any recognized University.
b) If B. Mus. (Sattriya) is not available trained up person with practical knowledge of Sattriya Music.


- Note :
- A. Specification for " Knowledge of Sattriya Music & Dance" shall be considered as-
 - i) Diploma in the subject from a recognized Board or University.
 - ii) A well-known and recognized person in the field of Sattriya Music & Dance.
 - B. Specification for "Trained up person of Sattriya Music & Dance" may be considered as a recognized person, of a reputed Sattri, in the respective subject.
In this context the following Diplomas can be considered for the purpose:
 - i) "Bisharad" of Sattriya Academy, Jorhat, Assam.
 - ii) "Parangad" of Asom Sattri Mahasabha, Jorhat.
 - iii) "Gunin" of Sangit Sattri, Guwahati.
