**The Terms of References-**


1. The Committee shall study the status of human resources in the colleges in terms of the department/ subject wise strength of teaching and non-teaching staff.
2. It shall study the status of infra-structure of the colleges in terms of classrooms, classroom equipments, library, laboratories and recreational facilities.
3. It shall also study the ICT facilities in the colleges in terms of digital classrooms, classrooms with ICT facilities, computer laboratories, language laboratories, internet connectivity, and electricity supplies.
4. It shall also study the inflow of funds from different agencies and their utilization in last five years.
5. The Committee shall submit its report within three months from the date of this notification.
