1.	Wall lining with Eco bloc Gypsum boards12.5mm thick Ecobloc gypsum boards is screw fixed with 25mm long Drywall screws at 230 mm centers. The screw fixing of standard gypsum boards to the metal framing at the periphery, openings and cut edges should be at 150mm centers.(SIZE 48X11X2+24X11X2)
2.	16mm thick ceiling panel having SQ edge of size 595x595 shall be placed into the above grid of size 600x600mm. This ceiling panel confirms to ASTM E84 surface burning characteristics. (Class A, Flame Spread: 25 & Smoke developed:50)(SIZE48X24)
3.	Floor carpeting(SIZE 48X24)
4.	Making of stage floor and back drop and stage light solution
