- Arrange for feedback response from students, parents and other stakeholders on quality-related institutional processes;

- Organize inter and intra institutional workshops, seminars on quality related themes and promotion of quality circles: e)
- f) Document various programmes / activities leading to quality improvement;
- Act as a nodal agency of the University for coordinating quality-related activities, including adoption and dissemination of g)
- Advise the University for development and maintenance of institutional database through Management Information System h) (MIS) for the purpose of maintaining / enhancing the institutional quality;
- Advise the University for development of Quality Culture in the University;
