Sub: Examination anomalies at North Bank College, Ghilamara, Lakhimpur-regarding.


It is hereby notified for information of all concerned that on the basis of the recommendations of the meeting of the Examination Committee of Dibrugarh University held on 3rd October, 2018, **North Bank College, Ghilamara, Lakhimpur District** has been demoted as a **Sub Centre** under Dhemaji College for the conduction of the ensuing 1st, 3rd and 5th Semester B.A. /B.Sc. Examinations to be held in the month of November, 2018. A Senior Teacher from Dhemaji College shall be assigned the responsibilities of Officer in Charge for the ensuing examinations to be held at North Bank College. This has been done in view of certain very serious anomalies occurred at North Bank College during the conduction of B.A. 6th Semester Examinations held in May, 2018.

Further the under mentioned Officer in Charge and the three Assistant Officers in Charge of North Bank College responsible for conduction of the aforementioned Even Semester Examinations, May, 2018 have been barred from assigning all kinds of examination related activities of Dibrugarh University, viz. Paper Setting, Moderation, Evaluation, Duties as Observers, Conduct of examinations, etc. till further order:


The other disciplinary proceedings against North Bank College (*if any*) shall be finalized by the competent authorities of Dibrugarh University in due course of time.
