Notice Inviting Quotation

Sealed quotations are invited from reputed firms/suppliers/ vendors for the supply of Liquid Nitrogen for NMR on "Rate Contract Basis" as per particulars mentioned below:

The quotations will be received by the undersigned on or before 21/06/2019 upto 11:00 A.M. and will be opened on the same date at 11:30 A.M. in the presence of the intending quotationers or their authorized agents.

Terms and Conditions:

- 1. The Contract Period for the supply of Liquid Nitrogen shall be valid for 2 (two) years only.
- A Security Deposit of Rs. 50,000.00 shall have to submitted by those vendor/supplier only
 who qualifies for the award of contract in the form of **Demand Draft only** drawn in favour of
 the Registrar, Dibrugarh University. The same will be refunded (without any interest) on the
 expiry of the Contract Period.
- 3. No separate quotation paper will be issued from the office. Quotation should be submitted in the Supplier's Letter Pad with supporting documents.
- 4. The University reserves the right to accept or reject any or all the quotations without assigning any reason.
- 5. The quotation should be addressed to the "Registrar, Dibrugarh University, Dibrugarh 786004" super scribing the Quotation Notice Number on the envelope.
- 6. In the event of any kind of holiday, the quotations shall be opened on the next working day.
- 7. Any kind of Taxes/GST (if any) or any kind of installation or other charges must be clearly indicated in the quotation.
- 8. The tendering firm must have proper PAN/GST No. and the same shall have to be enclosed with the quotations.
- 9. The quantity mentioned may be increased or decreased at the time of placing order as per requirement.
- 10. The tendering firm must have a permanent establishment in Assam.
- 11. In the event of any kind of holiday, the quotations shall be opened on the next working day of the University.
- 12. The Liquid Nitrogen should be 99.99 % pure.
- 13. The LN2 will be received in the cold liquid nitrogen containers and will be measured as per the capacity of the containers in litres. It will be the duty of the concerned officer/officials to provide the cold containers to the suppliers.
- 14. Rate should be quoted inclusive of delivery charges of filled containers/pick-up charges of empty containers to and from CSIC, Dibrugarh University.

- 15. If any damage is done to any LN2 containers while handling or in custody of the supplier, the container must be replaced with new container of same make and model or equivalent within 15 days by the supplier.
- 16. The supplier must have the capacity to supply at least 1,000 litres of Liquid Nitrogen within 5 days from the date of order. The volume of LN2 order may vary from 50 litres to 1,000 litres at a time.
- 17. If the supplier fails to supply the LN2 within stipulated time, then the intender can purchase LN2 from any other source and the difference of market rate and the approved rate will be recovered from the pending payment or the security deposit.
- 18. It is mandatory to enclose the test report from the recognized laboratory depicting purity deposit.
- 19. The Contract for the supply of liquid nitrogen may awarded to one or more vendor(s) as deemed fit by the authority to ensure fail-proof availability of supply.
