The Committee shall

- recommend appropriate subjects on which books of general interest and importance shall be written for publication by the University.
- ii) recommend panel of prospective authors for developing the manuscripts of the selected subjects.
- iii) recommend appropriate subjects on which textbooks for various academic programmes of the University, both for the undergraduate and postgraduate programmes be developed on a priority basis.
- iv) recommend panel of authors for developing the manuscript for the chosen subjects for textbooks.
- v) put forward general policy frame-work for the Publication Division.
- vi) recommend strategies for enhancing the culture and the polity of Assam and the North-East through publications of specific nature.
- vii) recommend strategies for marketing and wider circulation of the University publications.
- viii) The Committee will be for a period of three (3) years from the date of this notification or any subsequent notification, whichever is earlier.
