## XIX CONVOCATION, 2020

#### NOTIFICATION

The XIX Convocation of Dibrugarh University will be held tentatively in the month of February, 2020. In the Convocation, degrees shall be conferred on the eligible candidates who had qualified for all degrees of the University (having cleared their Final Semester Examinations) during the period from 01.11.2018 to 30.11.2019. However, only the Certificates of Post Graduate, M.Phil. and Ph.D. Degrees shall be distributed during the Convocation. The Certificates of other Degrees shall be distributed on dates and venues, which shall be notified later on.

The Submission of *Online Application* of the XIX Convocation of Dibrugarh University by the eligible intending candidates shall begin from 01.11.2019. The last date for submission is 15.12.2019 (till 05:00 P.M.).

#### **IMPORTANT**

- 1. For submission of the *Online Application Form*, intending candidates are advised to follow the following instructions:
  - a) The candidate shall have to register in the XIX Convocation portal at <a href="https://www.dibru.online">www.dibru.online</a> by entering Full Name, Username, Password and a Mobile Number to login. The Candidate will also be able to login to the System directly if they have registered gmail account. The candidate will get an "Activation Code" in the mobile which is to be entered for Activation.
  - b) After Activation, the candidates shall have to log in with his/ her user name and password and has to fill up the *Online Application* with correct and appropriate information.
  - c) The applicants are advised to enter their personal details in the prescribed format carefully. From this session onwards the Certificates shall be issued in bilingual (Assamese and English) format. Therefore, the Applicants need to enter their names in Assamese script as well.
  - d) The applicants shall have to pay the *Convocation Fee of Rs. 700/-* only through the *online payment gateway* by using Debit Card/Credit Card/ Internet Banking during the submission of form. *No other mode of payment is acceptable.*
  - e) The applicants can save and review the information entered before *Submission*, which can be edited on subsequent login. However, after Submission, editing of information shall not be possible.
  - f) On submission of the Online Application Form by an applicant, a Submission Receipt with a Unique Number shall be generated against each successful submission of Application. However, a successful submission shall not imply that

the application of a candidate is considered as correct and valid. This shall be ascertained after further verification by the University.

- g) After submission, the Application Form shall be generated in PDF Format, which may be saved or printed for future use. The applicants are advised to take a print of the *Online Application Form* for any future reference.
- 2. The Submission of Online Application Forms shall be automatically closed after the last date.
- 3. There shall be no alternative procedure for Application for participation in the XIX Convocation and the University shall not receive the Application Fee except the procedure mentioned at 1 (d) above.
- 4. The subsequent notification related to XIX Convocation shall be notified by the University from time to time.
