Examination Forms are invited from the colleges for eligible candidates for admission into the B. A. / B. Sc. / B. Com. 1st, 3rd and 5th Semester (Non CBCS) Examinations to be held in the month of November-December, 2019. The hard copy of the Computer Generated Examination Forms will be issued to all colleges from 25th September, 2019 onwards which are to be collected from the EDPS Section of the University. The soft copy of the Excel sheet containing the list of candidates along with the other details shall be available in the University website www.dibru.ac.in

The last date for submission of filled in Examination Forms of the candidates along with the soft copies and requisite fees in the University is 15th October, 2019 (without late fine) and 17th October 2019 (with late fine) without fail. Incomplete forms, Excel sheets without marking 'Y' or 'N' in the 'App' column, Elective Paper Codes, forms without fee and forms received after the last date will be rejected straightway and no correspondence will be entertained in this behalf. Colleges are requested to submit the Examination Forms well ahead of the last date in order to avoid the last minute rush and inconvenience.

The colleges that have not deposited the affiliation fees / permission fees, annual affiliation fee of the sports board and fees for section permission etc. to the University are requested to clear the outstanding fees before submission of Examination forms and fees. paid. For details, the concerned colleges may contact the office of the Director, College Development Council.

The Examination Fees should be deposited in the form of Bank Draft drawn in favour of the Registrar, Dibrugarh University payable at Punjab National Bank, Dibrugarh University Branch or through RTGS (A/C No. 0157002100032540, IFSC Code: PUNB0994000, MICR Code: 786024003) and a receipt confirming the payment should be taken from the Finance and Accounts Branch of the University.
- 5. For any queries related to the hard copy of the Examination Forms and the Excel sheet, the EDPS Section of Dibrugarh University may be contacted.
- 6. All the Principals of the Colleges are requested to inform the examinees well ahead so that no one is left out from the process of filling up the examination form within the last date. They should take special care so that the eligible candidates that have deposited the examination fee have signed on the examination form too. The University shall not accept examination forms from individual candidates and as such colleges should not forward/request the University in this regard.
